APPENDIX 3

GENERAL ABBREVIATIONS

Abbreviations are an integral part of legal citation. This appendix contains the following types of abbreviations:

- (A) Calendar divisions (months and days);
- (B) United States and world geography (states and territories, major United States cities, countries, and regions);
- (C) Subdivisions, such as sections and paragraphs;
- (D) Publishing terms, such as edition information; and
- (E) General abbreviations that can be used whenever a specific rule permits or requires words to be abbreviated.

Three other appendices also contain abbreviations. **Appendix 4** contains abbreviations for various state and federal courts. **Appendix 5** contains abbreviations for legal periodicals. In addition, a few abbreviations are listed in charts within the main text.

To form the plural of a listed abbreviation, simply add “s” to the end, unless the entry indicates otherwise.

COURT ABBREVIATIONS

This appendix contains abbreviations for state and federal courts. If you cannot find an entry for the court you wish to cite, consult **Appendix 3**, which contains general abbreviations. Also, consult **Appendix 1** when using court abbreviations in case citations.

A. State Courts

The listed state courts include each state's court of last resort, any intermediate appellate court, and trial courts of general jurisdiction. It is important to note that some states, such as New York and Pennsylvania, have additional courts. Courts are listed hierarchically, with the highest court in the state appearing first. For appellate courts, follow Rule 12.6(b) about adding counties, departments, and divisions.

The abbreviation for “District” is “D.” Many states have more than one district; these districts are designated by geography. The choices may be Central (C.), Eastern (E.), Middle (M.), Northern (N.), Southern (S.), or Western (W.). To formulate the abbreviation for a United States District Court, put the geographic designation before “D.,” and then add the state abbreviation. For state abbreviations, see **Appendix 3(B)**. Consult **Rule 2** for information about how to space the abbreviation.

APPENDIX 5

ABBREVIATIONS FOR LEGAL PERIODICALS

Use this appendix to abbreviate the names of periodicals. The citation form for periodicals is addressed in **Rule 23**. Selected periodicals are listed in alphabetical order by the periodical's current name. Prior names are listed immediately below the current name. Use the abbreviation that corresponds to the volume you are citing; do not use the current abbreviation if citing older volumes.

To help you determine how to space each abbreviation, the symbol **▲** has been used to designate a space. Do not include this symbol when you type the abbreviation.

The symbol **★** has been used to indicate whether a periodical is nonconsecutively paginated. Under item 3 in **Rule 23.1(f)**, when the issues of a particular periodical are not consecutively paginated, include the exact date contained on the first page or cover. For consecutively paginated periodicals, include only the year (item 2 in **Rule 23.1(f)**).

Although this list contains many periodicals, the list is not exhaustive. If you cannot locate the name of the periodical you wish to cite in **Appendix 5**, to construct the abbreviation, look up each word in the title in **Appendix 3**; you may also abbreviate any word that appears in another title within **Appendix 5**. If you cannot find an abbreviation for the word in **Appendix 3** or in **Appendix 5**, spell out that word. Remember to use **Rule 2** to properly space your abbreviation. Finally, omit the words "a," "at," "in," "of," and "the" from a periodical title, unless the reader would not be able to discern the publication name; also omit colons, and everything following them, that may appear within the title.
